### **Privacy Policy**

Your privacy is a top priority at SPAX®. This Privacy Policy covers our treatment of personal information that this site gathers when you visit. For details, continue reading:

### **Information We Collect**

#### **Our visitors - Automatic Data Collection**

Like most websites, spax.us collects non-personally identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Our purpose in collecting non-personally-identifying information is to better understand how our visitors use this website. From time to time, we may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of this website.

Spax.us also collects potentially personally identifying information like Internet Protocol (IP) addresses. #### **Our Customers - Information You Provide to Us**

Certain actions on our website do require us to collect personally identifying information. SPAX® collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with our company. We will never disclose personally-identifying information other than as described below.

#### **Aggregated Statistics**

SPAX® may collect statistics about the behavior of visitors to its websites. However, SPAX® will never disclose personally identifying information other than as described below.



## Protection of Certain Personally-Identifying-Information

SPAX® may find it necessary to disclose potentially personally-identifying and personally-identifying information to only to those of its employees, contractors, and affiliated organizations that (i) need to know that information in order to process it on our behalf, or to provide services requested by the customer, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors, and affiliated organizations may be located outside of your home country; by using spax.us, you consent to the transfer of such information to them. **SPAX® does not rent or sell potentially personally identifying and personally identifying information to anyone.** Other than to its employees, contractors and affiliated organizations, as described above, SPAX® only discloses potentially personally-identifying and personally-identifying information if required to do so by law, or when we believe in good faith that disclosure is reasonably necessary to protect the property or rights of SPAX®, third parties or the public at large. SPAX® takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally identifying and personally identifying information.
